I authorize social service agency representatives to provide information to my service provider verifying my participation in a qualifying public assistance program. I authorize my service provider to release any records (including financial records) required for the administration of the Lifeline/Link-Up programs.

I understand that I may be required to periodically verify my continued eligibility for Lifeline assistance and that failure to do so will result in the termination of Lifeline assistance and other changes in the terms and conditions of my service. I understand that Lifeline service and pricing may be subject to additional terms and conditions specified in a separate service agreement with my service provider.
